**RECOGNITION ORDER**

23 NOV 2017

WHEREAS in terms of section 14(1)/15(1) of the NCTE Act, 1993, the institutions had submitted applications to the Northern Regional Committee of NCTE for grant of recognition/permission for Teacher Education Courses.

2. AND WHEREAS on scrutiny/perusal, veracity of the facts & figures as per the application submitted by the institutions mentioned in table below, the documents attached therewith, the affidavit and the input received from the visiting team in the form of visiting team report including videography and also the reply submitted by the institution against decision of clause 7(13) of the NCTE Regulations, 2014, the Northern Regional Committee in its meeting held from time to time (mentioned against each of the institution) is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the concerned Teacher Education Programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory, etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms and as per the approval of faculty given by the affiliating bodies.

3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a)/15(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to the following Institutions for conducting Teacher Education programme with an annual intake mentioned against their names from the academic session 2018-2019 under clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfilment of the conditions mentioned below.

4. The institutions shall adhere to the fulfilment of the provisions of the NCTE Regulations, 2014 and ensure the following before commencement of the session:-

- The institution shall comply with various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- The institution shall comply with the condition as laid down in the clause 8(3) of the NCTE Regulations, 2014 which provided that "An institution which has been recognized by the Council shall obtain accreditation from an accrediting agency approved by Council within five year of such recognition."
- The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- The Norms of staff/ qualifications/administrative and professional staff/terms and conditions of service etc. shall be as per the provisions of NCTE Regulations, 2014.



5. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable and compliance of the following by the affiliating body, State Govt and also the concerned recognised Institution:-

- (i) The affiliating bodies/State Govt. shall be required to verify the authenticity of the land & building documents with the required land & built up area as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.
- (ii) The affiliating body shall ensure that the institution is composite institution as per the definition of composite institution given in the NCTE Regulation, 2014. If at any stage, it is found that the institution as not a composite institution, the recognition, granted will be treated as withdrawn and the sole responsibility of the same will be of the institution. However, in the existing institutions permitted for additional intake, shall have to ensure that they are to become composite gradually preferably the academic session 2016-17.
- (iii) The NOC of the affiliating body and staff approval thereof submitted by the institution, if found fake at any stage, the recognition, granted will be treated as withdrawn and the sole responsibility of the same will be of the institution.

6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

7. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- (i) Copy of the Application Form
- (ii) Land and Building Particulars
- (iii) Staff Profile
- (iv) Recognition letter
- (v) Information for having fulfilled the norms & standard and other required conditions.

8. In case if the land is in the name of the Society/trust, the land is to be transferred within six months in the name of the institution, failing which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate about the same to the respective Regional Committee along with the new land documents within the stipulated time.

9. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

10. The Educational Institution shall follow Uniform Accounting System as brought out by ICAI and accepted by MHRD.

11. The Institution shall fill the GIS Application within one month of issue of this order.

12. Further, if the institution is not satisfied with the order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website [www.ncte.india.org](http://www.ncte.india.org) within 60 days from the date of this order. The guidelines for filing appeal may be seen on NCTE's website.

उपरोक्त विषय के सम्बन्ध में शासनादेश संख्या- 1103 (1)/सत्तर-6-2014-2(97)/2014, दिनांक-01 अगस्त, 2014, जिसके द्वारा शैक्षिक सत्र 2014-15 से नवीन महाविद्यालयों/पूर्व में संचालित महाविद्यालयों में नवीन पाठ्यक्रमों के संचालन हेतु उत्तर प्रदेश राज्य विश्वविद्यालय (द्वितीय संशोधन) अधिनियम 2014 (उत्तर प्रदेश अधिनियम संख्या-14 सन् 2014) द्वारा उत्तर प्रदेश राज्य विश्वविद्यालय अधिनियम, 1973 की धारा 37 (2) के परन्तुक के अधीन राज्य सरकार की सम्बद्धता की पूर्वानुमति दिये जाने के सम्बन्ध को समाप्त कर दिया है, के क्रम में शहजादा मुस्लिम महाविद्यालय करमा, बहुअरा, दिलदारनगर, गाजीपुर को स्नातक स्तर पर शिक्षा संकाय के अन्तर्गत बी०ए० पाठ्यक्रम (द्विवर्षीय) में 50 सीटों की प्रवेश क्षमता सहित स्वयंसेवायुक्त योजनागत निम्नलिखित शर्तों के अधीन दिनांक-01.07.2018 से आगामी दो वर्षों हेतु अस्थायी सम्बद्धता प्रदान की जाती है-

1. महाविद्यालय शासनादेश संख्या-2851/सत्तर-2-2003-16(92)/2002, दिनांक-02 जुलाई, 2003 में उल्लिखित सुसंगत दिशा-निर्देशों एवं इस विषय में समय-समय पर निर्गत अन्य शासनादेशों का पालन करेगी।
2. शासनादेश संख्या-5267/70-2-2005-2(166)/2002 टी.सी. दिनांक-16.11.2005 एवं शासनादेश संख्या-5125/70-2-2005-2 (166) 2002, दिनांक- 21.10.2005 में दिये गये निर्देशों का अनुपालन संस्था द्वारा सुनिश्चित किया जायेगा।
3. महाविद्यालय/संस्थान द्वारा बी०ए० पाठ्यक्रम में शासन/एन०सी०टी०ई० जयपुर द्वारा अनुमत्य समस्त सीटों को सुसंगत अद्यतन शासनादेशों के अनुसार किसी शैक्षणिक सत्र में होने वाली संयुक्त प्रवेश परीक्षा में सम्मिलित एवं काउंसिलिंग के माध्यम से आवंटित अभ्यर्थियों के माध्यम से ही भरा जायेगा तथा राष्ट्रीय अध्यापक शिक्षा परिषद द्वारा निर्धारित मानकों के अनुसार शैक्षिक दिवसों में पढ़न-पाठन कराया जायेगा।
4. संस्था राष्ट्रीय अध्यापक शिक्षा परिषद द्वारा निर्धारित समस्त मानकों को पूर्ण तथा उनकी निरन्तरता को सुनिश्चित करेगी एवं परिषद द्वारा निर्धारित समस्त शर्तों का अनुपालन करेगी।
5. यदि संस्था द्वारा विश्वविद्यालय की परिणियमावली/अप्यादेश में वर्णित तथा शासन एवं विश्वविद्यालय द्वारा निर्धारित शर्तों एवं मानकों की पूर्णता तथा उनकी निरन्तरता को सुनिश्चित नहीं किया जायेगा, तो उत्तर प्रदेश राज्य विश्वविद्यालय, अधिनियम, 1973 के प्रावधानों के अन्तर्गत संस्था को प्रदान की गयी सम्बद्धता वापस लिए जाने की कार्यवाही नियमानुसार की जायेगी।
6. महाविद्यालय की भूमि आदि में किसी भी प्रकार की कोई कृति एवं तथ्य गोपन सम्बन्धी तथ्य प्रकाश में आने पर सम्बद्धता स्वतः समाप्त समझी जायेगी।
7. शासन के पत्र संख्या-12/2015/450/सत्तर-2015-16 (33)/2015, दिनांक-12 जून, 2015 में दिये गये निर्देश के क्रम में महाविद्यालय की वेबसाइट पर महाविद्यालय के प्राचार्य/प्रवक्ताओं आदि से सम्बन्धित समस्त सूचना अपलोड करेगी।

9. A.I.S.H.E. के अन्तर्गत रजिस्ट्रेशन समस्त अधिन वर्षों के अन्तर्गत।
10. सम्पूर्ण विश्वविद्यालय परीक्षा शुल्क का भुगतान अधिन वर्षों के अन्तर्गत।
11. कक्षा संचालन एवं N.C.T.E के मूल पत्र के सत्यापन के अन्तर्गत।
